

Terms of Services

Welcome to WeVoyce™. WeVoyce is mobile application offered to you by WeVoyce, Inc. (“us”, “we”, “our” and equivalently “WeVoyce”), conditioned on your acceptance without modification of the terms, conditions and notices contained herein governing your access to and use services (the “Terms”). The Terms shall govern your use of our services, SMS, APIs, notifications and included services WeVoyce offers on its platform (“Services”), and any information, text, link, graphics, photos, audio, videos, and any material, information, data uploaded, downloaded or appearing on the Services (“Content”). The terms “you”, “your” and “user” refers to your use of WeVoyce constitutes your agreement to all such Terms. If you are accessing or using the Services on behalf of an organization, company government or other legal entities then you represent and warrant that you are authorized to bind such entity to the Terms. Please read these Terms carefully. The WeVoyce Guidelines and Use Guidelines, the Privacy Policy and WeVoyce Site Restrictions (along with all incorporated policies) collectively under the “WeVoyce User Agreement”.

1. Your Account

If you use the Services, you are responsible for maintaining the confidentiality of your account and password and you agree to accept responsibility for all activities that occur under your account or any password, which should be strong and be limited in its use to this account only. You may not assign or otherwise transfer your account to any other person or entity. You acknowledge that WeVoyce is not responsible or liable for third party access to your account that results from theft or misappropriation of your account. WeVoyce and its associates reserve the right to refuse or cancel Service, terminate accounts, or remove or edit Content in our sole discretion.

2. Authorized Users

WeVoyce does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use WeVoyce only with permission of a parent or guardian. You must be at least 16 years of old to use the Services. You are granted a non-exclusive, non-transferable, revocable, perpetual license to access and use Services strictly in accordance with these Terms of use. As a condition of your use of the Service, you warrant to WeVoyce that you will not use the Services for any purpose that is unlawful or prohibited by these Terms. You may not use the Services in any manner which could damage, disable, overburden, or impair the Services or interfere with any other party's use and enjoyment of the Services. 4. Content

This license authorizes us to make your Content available to others and to let others do the same. You agree that this license includes the right for WeVoyce to provide, promote, and improve the Services and to make Content submitted to or through the Services available to other entities or individuals subject to the Terms herein. No compensation will be paid with respect to the use of your Content, as provided herein. WeVoyce is under no obligation to post or use any Content you may provide and may remove any Submission at any time in WeVoyce's sole discretion. By using the Services you agree that you may be exposed to Content that are inaccurate, inappropriate, offensive and information which could be injurious. You agree that you do not have the right to delete any Content you provide to WeVoyce Services and acknowledge that any Content provided to the Service may be available under the Services in perpetuity.
